### Safety Report

- Safety at a Glance Report measure of performance of Frequency of Insurance Cases, OSHA Recordable Cases, Lost Time Cases, Lost Work Days & 3<sup>rd</sup> Party Liability Cases.
  - Lower incident rates among Frontline companies. PK and McShea are up from previous year. Contributing factors, two major injuries at McShea and a major injury at PK
  - Goal is to have an incident rate at or below the NAICS rate. Incident rate higher than industry standard can trigger an OSHA audit.
  - Imperative to work toward OSHA compliance in all areas.

- [Arrowsight](#): Remote Video Auditing (RVA) “Game Film for Business”. RVA assists with work site risk management by targeting workplace areas, work zones, job sites. Propose pilot test one RVA unit.

Cost \$ \$35,000 to set outfit 4 trucks with 6 cameras per unit. Set up camera system in winter for 2023 use.
