Topics – WORK ZONE ACCESS

Entering and exiting a work area is part of the job that presents challenges to work crews and motorists that become more hazardous as traffic volumes and traffic speeds increase.

This tool talk discusses methods to safely enter and exit the work area inside a closure with minimum traffic disruption without exposing workers to traffic.

- Think ahead If possible, identify established ingress/egress points before arrival to the job and communicate the location to the entire crew. An ingress/egress point should be the location where construction vehicles enter and exit the work area with minimum traffic disruption without exposing workers to injury.
- Be Visible Strobes are to be flashing when working in a work zone
- Slow down Enter the work area at a speed that allows you to safely maneuver around traffic control devices and enter the closure.
- Anticipate Expect motorists to follow you into the closure. Once you are inside the closure carefully stop and check to make sure that you were not followed by motorists.
- Be patient When exiting the work area wait for a break in traffic that will allow enough time to accelerate safely.
