Topics – Commercial Driver's License (CDL) Policy (Handbook Update)

This tool talk updates the PK Employment Policies Handbook CDL policy in response to a new Federal Motor Carrier Safety Administration (FMCSA) rule. The new rule establishes new minimum training standards to obtain or upgrade a CDL or add a hazardous materials (H) endorsement. The new rule requires drivers to complete training at authorized facilities listed on the FMCSA's Training Provider Registry.

Section 1: Employment

COMMERCIAL DRIVER'S LICENSE POLICY (CDL)

Driving vehicles owned by PK Contracting, Inc. requires a CDL license and many PK vehicles require a CDL-AX license. A CDL–C is required to be hired. Advancement and pay is connected to obtaining a CDL-AX which includes the hazmat (H) and tanker (N) endorsement. Before obtaining the Class-AX license new drivers must successfully complete a mandatory knowledge and behind-the-wheel (BTW) training program at a facility listed on the Federal Training Provider Registry (TPR).

CDL TESTING COSTS

After a 60 day probationary period and if necessary, PK will pay the testing costs for new employees to obtain a CDL-AX license. The employee will reimburse PK through payroll deduction within two months during the construction season. PK will reimburse employees training costs to obtain a CDL AX license after being hired if the employee is still employed by PK two years after obtaining the CDL AX license.
