#### **CREW SPECIFIC SAFETY REVIEW**

#### 2.07 Hearing Protection & Conservation

Prolonged exposure to loud noise can result in permanent hearing loss

## • 3.10 High Pressure Blowing

When using compressed air for blowing the operator shall wear safety glasses and hearing protection and be careful not to blow into traffic.

#### NO SHORTCUTS when setting up lane closures

Take the time to set-up lane closures properly with cone tapers and tangents.

- **Listening Devices and Speakers** Earbuds, headphones or other listening devices are prohibited while on the job.

### **FOREMAN WORK REPORTS**

Foreman's reports need to be completely filled out with more than just quantities and time. Fuel usage must be reported for every vehicle everyday along with any hotel or other expenses. Information provided on the daily reports is also used to track and find the cause of incidents and eliminate a recurrence.
